Separate Applications are invited for 6 posts of Deputy Director of Health Services, Maharashtra Medical & Health Services, Group-A.

Details regarding vacancies are as below :-

1) Scheduled Castes & Scheduled Castes converted to Buddhism -----	1
2) Nomadic Tribes (C) -----	1
3) Open -----	2+2*

[ \* Indicates posts reserved for ladies, if available]

[ The reservation specified for the N.T.(C) shall be intertransferable. If suitable candidates for the posts reserved for N.T.(C) are not available, the posts shall be filled by suitable candidates from any of the other categories amongst D.T.(A), N.T.(B) & N.T.(D) as per Govt. orders/Act.]

### 2. Reservation for Physically challenged persons:-

2.1 As per Govt. Notification, Public Health Dept., No. Apang 2004/55/Samanvay 2, dated 27<sup>th</sup> February, 2009 amongst Physically Challenged candidates Only Partially Sighted, Partially Deaf and Locomotor Disability (Only One leg affected) candidates are eligible for this post. But as per G.R., Social Justice & Special Assistance Department No. Nyaypra 2006/C.R.9/Part-1/Sudhar-3, dated 13<sup>th</sup> August, 2009 instead of "Partially Sighted", "Blind / Low Vision" has been notified and candidates only who submit the certificate mentioning clearly such type of disability will only be considered for the post.

### 3. PAY :

- 3.1 Rs.15600-39100 Grade Pay-Rs.7600/- plus other admissible allowances as per prevalent rules.[Total Emolument Approx.Rs.36424/-p.m.]
- 3.2 Higher Starting pay is admissible in case of candidate with exceptionally higher qualifications and experience, when suitable candidate are not available on the minimum.
- 3.3 The extent of higher starting pay will be decided by the Govt. on merit of each case.

### 4. AGE :

- 4.1 Not more than 45 years as on 1<sup>st</sup> August, 2010. Relaxable as per rules.
- 4.2 The upper age limit shall not apply to the employee of Government of Maharashtra.
- 4.3 Age limit may be relaxed by Government on recommendation of the Commission in favour of candidates having exceptional qualification or experience or both.

### 5. QUALIFICATION : Candidates must possess -

- 5.1 M.B.B.S. Degree of a Statutory University or any other qualification specified in the First Schedule or Second Schedule to the Indian Medical Council Act, 1956;
- 5.2 Post-graduate degree or post-graduate diploma in any of the qualifications specified in the first or second Schedule to the Indian Medical Council Act, 1956 or any other qualification recognised as equivalent thereto by the Medical Council of India, **AND**
- 5.3 Experience of Health administration, Medical relief or Family welfare under Government, Zilla Parishad or a Local Body for not less than 5 years in the case of those holding post-graduate degree and for not less than 7 years in the case of those holding post-graduate diploma, gained after acquiring the post-graduate degree or post-graduate diploma as the case may be and out of which experience for 4 years shall be in a Class-I post or in a post equivalent thereto.

6. **DUTIES & RESPONSIBILITIES** : The details regarding duties and responsibilities of the post are available on website of the Maharashtra Public Service Commission.

### 7. GENERAL :

- 7.1 Selected candidates will be on probation for a period of two years.
- 7.2 There are prospects of promotion to the post of Jt. Director of Health Services.
- 7.3 Selected candidates will be debarred from doing any private practice, but will be paid compensatory allowance in lieu thereof according to the rules
- 7.4 Selected candidates will be required to sign an agreement embodying the condition of service including the condition to serve Government for a period of five years or in default to pay a penalty of Rs.500/- or such other sum as may be prescribed by the Government.
- 7.5 Selected candidates will have to get themselves registered under the Maharashtra Medical Council Act, 1965, before joining the post unless he/she has already so registered or his/her name should be borne in the Indian Medical Register maintained under the Indian Medical Council Act, 1956.

### 8. NOTE :

- 8.1 The column No. 6.2 of the old application regarding 'Do your claim reservation' OR column No. 5.1 of the new application regarding 'Do you claim benefits of reservation such as Fee, Age and the post reserved for Backward Categories' shall stand deleted. However, the backward class candidates and general Female candidates belonging to the Non-Creamy Layer section will have to claim regarding NCL. In these circumstances, both the applications, old as well as new, submitted by the candidate, will be accepted by the Commission.
- 8.2 In addition the candidates should attach separate sheet of Proforma-A for details of qualification, along with application form, as per coloum No. 21 in new application form or 32.1 in old application form, failing which it will be treated as incomplete and will be rejected. Specimen of Proforma-A is available along with the said advertisement on the web site of Commission in 'Specimen sheet of details of qualifications' section'.
- 8.3 The Commission at its discretion, may shortlist the applications for interview, based on reasonable criteria i.e. experience and/or higher qualification, etc. OR may conduct Written objective type Screening Test (multiple choice question) to shortlist candidates for interview. The syllabus and medium of question paper and other details for the test shall be displayed on the Commission's web site.

- 8.4 The prescribed essential qualification is the minimum qualification and a mere possession of minimum qualification does not entitle candidates to be called for interview where the number of application received in response to an advertisement is large in numbers and it will not be convenient or possible for Commission to interview all the candidates, the Commission may restrict the number of candidates to a reasonable limit on the basis of qualification and experience higher than minimum prescribed in the advertisement.
- 8.5 All copies of certificates should be attached along with the Application Form, without which the form may be considered incomplete and rejected.
- 8.6 The candidate should submit all the original certificates at the time of interview as per instruction given in Chapter-4 of the Prospectus provided along with the application form.
