6. DUTIES & RESPONSIBILITIES : The details regarding duties and responsibilities of the post are available on web site of the Maharashtra Public Service Commission.

7. GENERAL : Selected candidates will be on probation for a period of Two years.

8. NOTES

- 8.1** The column No. 6.2 of the old application regarding ' **Do you claim reservation**' OR column No. 5.1 of the new application regarding '**Do you claim benefits of reservation, such as Fee, Age and the post reserved for Backward Categories**' shall stand deleted. However, the backward class candidates and general Female candidates belonging to the Non-Creamy Layer section will have to claim regarding Non-Creamy Layer (NCL). In these circumstances, both the applications, old as well as new, submitted by the candidate, will be accepted by the Commission.
- 8.2** In addition the candidates should attach Annexure proforma for Judicial post and Additional proforma for details of qualifications / experience along with application form. Failing which it will be treated as incomplete and will be rejected. (Specimen of Additional proforma is available along with the said Advertisement on the web site of the Commission).
- 8.3** The Commission at its discretion may shortlist the applicants for interview based on reasonable criteria i.e. experience and/or higher qualification, etc. OR may conduct Written objective type (multiple choice questions) screening test to shortlist candidates for interview. The syllabus and medium of question paper and other details for the test shall be displayed on Commission's Website.
- 8.4** The prescribed essential qualification were minimum qualifications and a mere possession of minimum qualification does not entitle candidate to be called for interview. Where the number of applications, received in response to an advertisement is large in number and it will not be convenient or possible for commission to interview all the candidates. The Commission may restrict the number of candidates to a reasonable limit on the basis of qualification and experience higher than minimum prescribed in the advertisement.

- 8.5 Zerox copies of required certificates should be attached along with the Application Form and also copies of certificates as mentioning Additional Proforma.
- 8.6 The Application Form should be accompanied by copies of certificates and summary sheets , failing which it is treated as incomplete and will be rejected.
