### 2. RESERVATION FOR PHYSICALLY CHALLENGED PERSONS :

The reservation for Physically Challenged persons is as per Govt. Circular, Social Justice & Special Assistance Department no. Apang-2007/C.R.61/Sudhar-3, dated : 20<sup>th</sup> April, 2007.

As per G.R., Women & Child Development Department No. MBA-2003/C.R.239/D-7, dt. 30<sup>th</sup> August, 2005 eligibility /non-eligibility in the sub-categories of Physically Challenged Candidates is mentioned below.

3. PAY : Rs.PB 2-9300-34500+4400/- Grade pay plus other admissible allowances as per prevalent rules.

4. AGE :

4.1 Not more than 33 years as on 1<sup>st</sup> November, 2010. Relaxable as per rules.

4.2 The age limit may be relaxed by ten years in case of candidates already serving in the Government of Maharashtra.

5. QUALIFICATIONS : Candidates must ----

posses a degree or post graduate degree in Arts, Science, Commerce, Agriculture, Law, Social Work, Psychology, Home Science or Nutrition of a statutory University or any other qualification recognised by the Government to be equivalent thereto:

6. SYLLABUS [DUTIES & RESPONSIBILITIES] : The details regarding duties and responsibilities of the post is available on web site of the Maharashtra Public Service Commission.

7. GENERAL :

Selected candidates will be on probation for a period of two years. There are prospects of promotion to the post of Child Development Project Officer/Assistant Commissioner/Assistant Director/Probation Superintendent Group - A.

8. NOTES :

8.1 The column No.6.2 of the old application regarding 'Do you claim reservation ' OR column No.5.1 of the new application regarding 'Do you claim benefits of reservation such as Fee, Age and the Post reserved for Backward Categories' shall stand deleted. However, the backward class candidates and General Female candidates belonging to the Non-Creamy Layer section will have to claim regarding NCL. In these circumstances both the applications, old as well as new, submitted by the candidate will be accepted by the Commission.

8.2 In addition the candidates should attach separate sheet of **Proforma-A** for details of qualifications, along with application form, as per column 21 in new application form or 32.1 in new application form. **Failing which, it will be treated as incomplete and will be rejected.** Specimen of **proforma-A** is available alongwith the said advertisement on the website of Commission in '**Specimen sheet of details of qualifications**' section.

- 8.3 The Commission at its discretion may shortlist the applicants for interview based on reasonable criteria, i.e. experience and/or higher qualification, etc. OR may conduct written objective type (multiple choice questions) screening test to shortlist candidates for interview. The syllabus and medium of question paper and other details for the test shall be displayed on the Commission's Website. For Written test exam negative marking system is adopted by the Commission. As per proportion **One mark** will be deducted for **Four wrong** answers.
- 8.4 The prescribed essential qualification is the minimum qualification and a mere possession of minimum qualification does not entitle candidate to be called for interview where the number of application received in response to an advertisement is large in numbers and it will not be convenient or possible for Commission to interview all the candidates the Commission may restrict the number of candidates to a reasonable limit on the basis of qualification and experience higher than minimum prescribed in the advertisement.
- 8.5 **All Copies of certificates should be attached along with Application Form without which the form may be considered incomplete and rejected.**
- 8.6 The Candidate should submit **all the original certificates at the time of interview** as per instruction given in Chapter-4 to the Prospectus provided along with the application form.
