journals included in Medicine, Pubmed Central, Citation index, Sciences Citation index, Expanded Embase, Scopus, Directory of Open access journals(DoAJ) will be considered).

The Author must be amongst first three or should be the corresponding author.

- II) Should have completed the basic course in Medical Education Technology from Institution(s) designated by MCI.
- III) Should have completed the basic course in biomedical research from institution (s) designated by MCI.

Further provided that for the transitory period of 2 years w.e.f. the date of notification, MCI dated 12.2.2020 the appointment / promotion to the post of Professor can be made by the institution in accordance with the "Minimum Quailifications for teachers in Medical Institutions Regulations, 1998" as prevailing before issuance of this notification.

OR

As per notification 31.10.2018 Associate prefessor in the subject for 15 years 7 months in a permitted/approved /recognized medical college / institution with 4 Research Publications in Indexed journal on Cumulative basis with minimum of 2 Research Publications during the tenure of Associate Professor as Ist Author or as corresponding author.
